Fraudulent financial reporting and misappropriation of assets are major problems for businesses of all sizes. Knowledge about how fraud is committed and how to spot the potential for fraud are valuable for managers at all levels.

Course Objectives

- Explain some of the common reasons companies experience misappropriation of their assets
- Identify and explain the elements of the Fraud Triangle
- Explain the major methods used to commit financial reporting fraud
- Link fraud schemes to financial statement impacts
- Identify and explain internal controls that can prevent or detect fraud
- Explain how bribery and corruption are different
- Explain why an organization may need to be concerned about fraud related to money laundering, false government claims, and insider trading
- Describe best practices in preventing other forms of fraud in your organization
- Describe the minimum requirements for organizations in structuring their compliance function under the Sentencing Guidelines.
- Describe the components of the COSO Enterprise Risk Management framework.
- Understand the role of company leadership in a compliance program.
